## REQUEST FORM FOR DRIVING SAFETY COURSE

Holders of COMMERCIAL DRIVER'S LICENSES are NOT eligible for DSC or Deferral

Under the laws of the State of Texas, you may request that one charge against you be dismissed by taking a driving safety course or motorcycle operator training course.

HOWEVER, YOU WILL LOSE THIS OPTION IF YOU DO NOT REQUEST IT IN PERSON OR IN WRITING BY YOUR APPEARANCE DATE AS SHOWN ON YOUR CITATION.

NOTE: The court DOES NOT accept a telephone call as an appearance

The option is available if you hold a valid Texas Driver's License or permit (NOT COMMERCIAL DRIVER'S LICENSE) or are a member of the U.S. Armed Forces on active duty with an out of state driver's license AND show proof of financial responsibility (insurance).

This option is NOT available if you are charged with speeding 25 mph or more above the posted speed limit or speeding 95 mph or more in any zone, if you hold a CDL driver's license, if you were charged with failing to stop and leave information or passing a school bus, have used this option to dismiss a citation in the last 12 months, or are charged for a violation occurring in a work zone with workers present.

If you wish to use this option to have this citation dismissed, complete the request form at the bottom of this page and return it to the Court with the required items/information listed below **ON OR BEFORE** your appearance date. Once you have been approved to take the course, you will receive a letter in the mail with all information needed to complete and return proof of completion to the Court.
